Cathy Stern, OD, FCOVD, FNORA, FSCO

maintains a private practice near Boston that is limited to vision therapy, syntonix phototherapy, and neuro-optometric rehabilitation. She is a current board member of the College of Syntonix Optometry (CSO) and faculty for NORA Curriculum II. Previously she was faculty for the CSO Basic Course, the COVD Brain Injury course, and a physician mentor for MIT ReDx (Rethinking Engineering Design Execution for Digital Health). Her current interests include helping optometrists add myopia control and vision therapy to their practices and visual processing for better use of assistive technology. Dr. Stern believes the eye and vision are key players in prevention, enhancement, and rehabilitation for lifelong success.

Charles Shidlofsky, O.D., FCOVD

Dr. Shidlofsky completed his Pre-Optometry studies at the University of Texas at Austin and attended Southern College of Optometry in Memphis, Tenn. where he received his BS in 1986 and OD in 1988. Upon graduation, he moved back to the Dallas area to begin his practice. Dr. S, as he is known around the office, has been very active in Neuro-developmental Optometry. He has developed and integrated many unique therapies that have helped thousands of children who have struggled in school due to vision problems often seen in: ADD/ADHD, Autism Spectrum Disorder, Sensory Processing Disorders as well as some of the classic vision problems related to focusing, eye teaming, eye movement skills, visual-spatial skills, and visual perception issues. He has expanded his work to include those with traumatic and acquired brain injury, stroke, and other neurological processing problems. In addition, he works with several professional sports teams in the Dallas area as well as weekend athletes on developing vision skills. Dr. Shidlofsky is a Clinical Director for the Special Olympics Opening Eyes Program. Dr. Shidlofsky completed his Fellowship for the College of Optometrists in Vision Development in 2011. He is an Adjunct Professor of Optometry at: Southern College of Optometry, University of Houston College of Optometry, University of Incarnate Word-Rosenberg College of Optometry and Western University College of Optometry. He is also director of a private practice residency program in pediatrics/vision therapy/sports vision and neuro-vision rehabilitation through Southern College of Optometry.

Randy Schulman, MS, OD, FCOVD

Dr. Schulman graduated cum laude from the University of Pennsylvania where she received her Bachelor of Arts degree in Psychology. She graduated with her Doctorate in Optometry and Masters in Vision Science degrees from the State University of New York, College of Optometry. Dr. Schulman received her Fellowship in the College of Optometrists for Vision Development and is an Associate member of the Optometric Extension Program, in addition to being an Adjunct Professor at the State University of New York College of Optometry. Dr. Schulman has lectured extensively on behavioral optometry topics such as vision in the classroom, vision and aging, visual difficulties in the developmentally delayed, and lectured and published on vision and autism. She specializes in behavioral optometry and vision therapy, pediatrics, learning disabilities and preventative, integrative and alternative vision care for all ages.

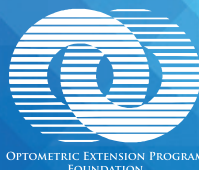
